Care of the Environment: Earth Challenge 2020

Earth Day's 50th anniversary celebrates its milestone anniversary this year on April 22. After its institution began in the United States in the 1970's, other countries followed suit and Earth Day became a global campaign. We face more challenges today than in years past with growing pollution that negatively affects biodiversity and ecosystems, threatening our existence and that of future generations. Organized by Earth Day Network, this year's theme is Climate Action. Proposed campaigns include Earth Challenge 2020—described as being the largest ever citizen scientist initiative that will aim to equip individuals with the necessary tools to report on the health and wellbeing of the environment.

We think of Saint Francis as synonymous with care and protection of all living things. He had a gentle yet steadfast love for all the creatures of the earth and all God's creation. Saint Francis was removed from the material world garnering tremendous spiritual insight and connection to our universe.

Pope Saint Paul VI, Pope Saint John Paul II, who declared Saint Francis the Patron Saint of Ecologists, and Pope Francis are popes who have championed a conscious and concerted effort to protect our environment. In the encyclical *Gaudium et Spes* (1965), Pope Paul VI asks us to consider the future of humanity and be strong enough to give reasons for life and hope for a coming generation. In *Redemptor Hominis* (1979), John Paul II states that we all have a responsibility to protect the environment. Pope Francis's encyclical *Laudato Si* (2015) on *Care for our Common Home* is the most recent Vatican document on the environment.

A great starting place for further research is Ted Bergfelt's freely available subject guide "<u>Laudato Si</u>" which provides links to papal documents, recent articles in the media and search terms for finding books and other materials in the <u>Catholic Portal</u>. For compelling newspaper accounts of the beginning of the global environmental movement, tap into the <u>Catholic News Archive</u>.

Selected Catholic newspaper articles on the environment:

- 8 August 1969. Endst, Jeff. *Are we destroying the world we live in.* Predictions about the effects of pollution on the earth's climate at the millennium. -*Pittsburgh Catholic*
- 25 March 1970. Famous, Filthy Cuyahoga. Cleveland Ohio's Cuyahoga River Ohio Water Pollution Act. -NCR
- 25 December 1970. Kasper, Rob. CAP Zaps Chicago Area Pollution. Father Dubi and the Campaign Against Pollution (CAP) takes on big companies for excessive environmental waste. -NCR
- 24 September 1979. New Books on Ecology. A listing of books of the time period containing environmental studies, ecological essays, originally published narratives and preventative solutions for the burgeoning environmental crisis. -NCR
- 12 May 1972. U.N. Conference to Study Environmental Influences. A detailed look at the
 preparatory committees' drafting of the declaration for the international conference, to be
 held in Stockholm, on six major areas of the environment. -Catholic Transcript, Hartford
- 16 June 1972. Weapons of War Cause Pollution. Traces the impact of weapons of war as major causation for adverse effects upon the environment. -Pittsburgh Catholic
- 23 June 1972. *Ecocide Concerns Churchmen*. The aftermath of the historic Stockholm conference holds many concerns for Vatican delegates and religious task force on issues not addressed such as ecocide and the population explosion. *-Catholic Transcript*
- 7 July 1972. *Editorial: Ecology and Theology.* A commentary on the results of the U.N. Conference emphasizing the problem of social justice. *-Pittsburgh Catholic.*
- 15 June 1973. Vatican Commission Views Eco Crisis. The Vatican Commission for Justice and Peace issues a report to the U.N. Conference outlining ecological concerns on the environment on its first anniversary. -Catholic Transcript

At the urging of librarians and scholars alike, the Catholic Library Association (CLA) is leading a collaborative project to digitize the remaining 18 volumes of its *General Index to Catholic Literature*, 1930-1980, with all issues made freely available in Villanova's Digital Catholica collection.

Introducing the Newly Formed Archival Resources for Catholic Collections (ARCC) and Your Participation

ARCC is a direct response to the need for a body of dedicated religious leaders, archivists and scholars to provide a coordinated effort to assist Catholic women's and men's orders and congregations in preserving their archives and, through them, their important legacy. This need was clearly articulated by the participants at the Boston College conference and was included as a recommendation in the post-conference working paper <u>Preserving the Past, Building the Future</u>. ARCC envisions itself as an organization that will:

- Synthesize and present as an integrated whole the unique perspectives of Catholic religious leaders, archivists and scholars in order to provide communities struggling with their archives reliable professional advice on how best to care for their records,
- Provide educational opportunities for archives, archivists and related personnel to assist
 with the development of professionally run archives,
- Create centralized online forums for knowledge and resource sharing and facilitated discussion to further collaboration and advocacy within the community.

Coordinated by Malachy McCarthy of the Claretian Missionaries Archives, the Steering Committee reflects the three groups represented at the Boston College conference: Catholic religious leaders, scholars and archivists. Its members include: Carol Coburn of Avila University, Ginger Downey of Our Lady of Victory Missionaries, archival consultant Ellen Pierce, Chris Doan of the Archives of the Archdiocese of San Francisco, Pat Lawton of the University of Notre Dame, Jennifer Halloran of the Maryknoll Mission Archives and Rachel Foote of the Sisters of the Presentation of San Francisco.

A Google group is the first step towards bringing the vision to life by providing community members a discussion forum where they can share their questions, concerns, ideas and advice. To join the Google group send an email to archivalrcc@gmail.com.

ARCC's next step, currently in progress, is to develop a public website which will provide access to resources and education for anyone with a vested interest in the preservation and use of Catholic religious archives. Content to populate this site in the areas of education, advocacy and collaboration will come from the efforts of working groups. Preliminary working groups will focus efforts on:

- · Educational programming for archivists
- Developing descriptive standards
- Repository guidelines

Catholic News Archive - Content Update

We have had a flurry of new content activity the last several months!

Late Last Year

Two big, marquee collections were finished and published to the site:

- The Catholic World in Pictures This rich and interesting collection is mostly pictures, carefully indexed to allow you to find interesting words and phrases. Currently available years: 1922-1927 and 1938-1963.
- La Esperanza Our first Spanish language paper, based in California but nationwide in coverage. Currently available years: 1930-1940 and 1948-1954.

Just Released

We have recently added two collections to the site, and added more years for two others:

- Catholic Commentator A new paper out of Baton Rouge, Louisiana. Currently available vears: 1963.
- **St. Louis Register** The more modern version of the Shepherd of the Valley newspaper. Currently available years: 1941-1957.
- Catholic Advocate More years! Currently available years: 1958-1968.
- The Catholic Standard and Times More years! Currently available years: 1833-1838; 1842-1844; 1963-1968.

Coming Soon

Currently in testing:

- More years for The Catholic Telegraph, from Cincinatti, Ohio.
- More years for The Clarion Herald, out of New Orleans, Louisiana.

Catholic University/CRRA Awarded Grant from USCCB


I am very happy to share the good news about our successful grant proposal to create enhanced online access to materials in Catholic University's Special Collections. We partnered with CRRA, who will administer the grant, and have been awarded \$15,690 from the Catholic Communication Campaign of the U.S. Conference of Catholic Bishops (USCCB) to support the enhanced processing of scanned materials from the National Catholic Welfare Council (NCWC) Bulletin (later Catholic Action), the NCWC Annual Reports and the National Council of Catholic Men program transcripts of the Catholic Hour. Our Special Collections serves as the archival repository to the USCCB of which these materials are a part.

These digitized materials will be added to the <u>Catholic University Digital Collections</u> and, thanks to the enhanced processing, to the <u>Catholic News Archive</u>. We are excited to both reach a broader audience and enhance scholarship through the aggregation with similar primary sources and improved search capabilities.

These materials are vital for understanding the scope of operations of the representative organization of the Catholic Church in the U.S., the USCCB/NCWC. Additionally, they offer a window into relations between the Catholic lay organization, the National Council of Catholic Men, and the U.S. Bishops. Finally, they offer a view of early twentieth century Catholic media on a national scale.

My huge thanks to John Shepherd, Maria Mazzenga and Shane MacDonald at Catholic University, Katherine Nuss at the USCCB, and Todd Jensen and Jennifer Younger of CRRA for their work in securing this grant.
