# 2. Catholic News Archive – Testimonial, Mary Brown, Archivist, Center for Migration Studies, NY

Recently, the <u>Catholic News Archive</u> was helpful in turning a folder of disparate papers into a story of refugee rescue. An intern at the Center for Migration Studies (CMS) was looking for something among the National Catholic Welfare Conference (NCWC) Bureau of Immigration records when I noticed the Bureau's Czechoslovakia file seemed thicker than the usual folder. To our astonishment we found documents from the 1930s describing the Czech Catholic immigrant aid agency's efforts on behalf of refugees from the Nazis. Our intern consulted a reference librarian, and the librarian turned to the Catholic News Archive.

A July 10, 1939 story (press release 39-2105, p. 9) with a bland title about "political changes" in Czechoslovakia described Czech Catholic efforts to aid co-religionists whose Jewish ancestry left them vulnerable to the Nuremberg laws recently imposed on their country. CMS's records indicated one of the people active in this effort was Josepha Kolarik, secretary of the Saint Raphael Society for Czech Immigrants. Václav Myslivec, a prominent Czech Catholic journalist, knew Kolarik, and his first report after World War II, distributed in an August 27 NCWC newsfeed (45-2255, p. 2, and 45-2271, p. 17), broke the news of her disappearance during the war. On November 19, 1945, another NCWC newsfeed (45-3080, p. 13) reported the end of Myslivec's search: Kolarik had died at Ravensbruck in 1943. The International Tracing Service at Bad Arolsen had information on two people named Kolarik; The NCWC newsfeeds' account of Kolarik's death made clear which data pertained to Josepha. The August 27 and November 19 newsfeeds provided additional details on Kolarik's last months of work: Myslivec repeatedly recalled how, harassed by the Nazis and ousted from her job-which also meant being deprived of her means of earning a living—Kolarik made a pact with Myslivec that whoever was still alive would find a way to tell the Americans what was happening in Czechoslovakia. Thanks to the NCWC News Service, Myslivec was able to fulfill that charge, and, thanks to the Catholic New Archive, the information and inspiration we found in our research are available to everyone.

### 3. Lane Award for Work in Religious Archives, Nominations Invited

The Society of American Archivists' (SAA) Awards Committee is seeking nominations for the Sister M. Claude Lane, O.P., Memorial Award. This award recognizes individuals who have made a significant contribution to the field of religious archives. Criteria for nomination include:

- Involvement and work in the Archivists of Religious Collections, Section (ARCS) of the Society of American Archivists
- Contributions to archival literature that relates to religious archives
- Participation and leadership in religious archives organizations
- Evidence of leadership in specific religious archives.

Only individual archivists are eligible for nomination. The award finalist is recognized with a certificate from SAA and a \$300 cash prize provided by the Society of Southwest Archivists at the annual Society of American Archivists meeting.

# 4. 2018 ACWR Triennial Conference "Gratitude for the Past and Hope for the Future", Call for Session Proposals (Dee Gallo, ACWR President)

ACWR 2018: Archives for Congregations of Women Religious September 13-15, 2018 The Brown Hotel–Louisville, Kentucky

The 9<sup>th</sup> Triennial Conference of the Archivists for Congregations of Women Religious (ACWR) will be held September 13-15, 2018, at the Brown Hotel in Louisville, Kentucky. Our theme for this conference is "Gratitude for the Past and Hope for the Future."

As archivists, we are firmly planted in the past, yet we must also focus on the present and future in these times of rapid change. Many of our communities are in transition: archives are closing or consolidating; positions formerly filled by women religious are now shifting to a lay staff that must be oriented to heritage and charism; and constantly-changing technologies challenge our abilities to arrange, retrieve and make accessible a new generation of material. This year's theme will allow presenters to demonstrate how they have dealt with such issues, highlight challenges, and introduce related issues.

ACWR is soliciting proposals for conference sessions based on this theme and welcomes proposals from its membership, independent researchers, historians, archivists, and others related to the conference's field of expertise. Traditional sessions and panel discussions are

welcome, but multimedia presentations, workshop sessions and roundtables are also encouraged.

Based on the results of our recent membership survey, proposals that address the following topics are particularly relevant:

- Technology, including an introduction on and creation of policies and procedures for digital materials, starting a digital program, digital preservation, and digitizing initiatives for small archives
- Storage and handling of object and audio-visual collections, including conservation issues
- Oral history programs and policies
- Administrative issues, such as mergers and plans or policies implemented for completing communities

Each breakout session is sixty minutes. All presentations in a session should be limited to forty-five minutes total to allow time for discussion. Also, proposals may be merged into a panel format if similar themes or projects are submitted.

A committee will evaluate proposals on the strength of a 300-word abstract, the speakers' experience, and relevance to the meeting theme. All proposals should include a title for the proposed presentation and a brief bio of the presenter(s).

## 5. NEH Grant to Hugh J. Phillips Library at Mount St. Mary's University (Julie Loy)

The Hugh J. Phillips Library at Mount St. Mary's University has been awarded a Preservation Assistance for Smaller Institutions grant from the National Endowment for the Humanities (NEH) to support a comprehensive preservation assessment. NEH funding provided through this grant program will be used to hire a LYRASIS professional preservation consultant to conduct a preservation needs assessment of collections, environmental conditions, facilities, and current departmental preservation policies and procedures to provide baseline data for departmental preservation improvement planning. Additionally, funding will support the installation of an automated environmental monitoring system that will continuously collect and report temperature and relative humidity within the areas that store collections.
