# The Oliver Leonard Kapsner, O.S.B. Cataloging Bulletin: A Resource for Catalogers of Catholic Publications

At some point in 2007 I was contacted by Tom Duszak of the Catholic Library Association with an invitation to start a newsletter aimed at catalogers in Catholic libraries. After some discussion I agreed to compile and edit such a publication, with the agreed-upon frequency to be quarterly. With that, the Oliver Leonard Kapsner, O.S.B. Cataloging Bulletin: e-newsletter of the Catholic Library Association was born, and the rest, as they say, is history. I've continued my endeavors since then and have just released the April 2016 issue (number 35).

The Bulletin offers current cataloging information which can benefit the work of catalogers to potentially enhance or update the information found in local catalogs. The main substance of the issues consists of updates, corrections or new entries in LC topical subject headings, genre headings and LC classification gleaned from the weekly lists made available through the Library of Congress website. In addition, new or updated name authority headings in the news are often highlighted separately. Finally, other pertinent news from the cataloging world is passed along. Recent topics have included Demographic Group Terms applicable to Catholic materials; news about the digitization of the National Union Catalog Pre-1956 Imprints; the list of Genre/Form Terms for Religious Works approved by the Library of Congress along with information about the collaborative work underlying it; the new CIP data block announced by LC; and other articles.

Still, a standing desideratum has been to see more contributed content to the Bulletin from the reading audience. The Catholic Research Resources Alliance represents a constituency that could step up in this regard, along with the membership of the Catholic Library Association.



# CRRA Subject Guides Subcommittee

In April 2016, CRRA began a subscription to LibGuides. In Spring 2016, a

the Collections Committee, also began to operate, with Ted Bergfelt (Duquesne University) as the chair. Members of this subcommittee include Dustin Booher (Catholic University of America), Andrew Rea (DePaul University), Steven Szegedi (Dominican University), and Desirae Zingarelli-Sweet (Loyola Marymount). The purpose of the subcommittee is to create subject guides (using the LibGuides software) that will help connect Catholic Portal users quickly and easily to relevant content, both print and electronic, at CRRA institutions and beyond. There are currently thirteen CRRA LibGuides, and two more are under development. The choice of topics for future CRRA LibGuides will be based on Catholic Portal search statistics, the twelve CRRA collecting themes, special events, and suggestions from Portal users and CRRA member institutions. #### **Annual Report of Liaisons Council activities:**

1. New appointment

On September 2015, Ximena Valdivia from Barry University was appointed chair of the Liaisons Council.

### 2. CRRA Liaisons Council meeting

On October 2, 2015, Council had the first meeting of the year. Agenda of the meeting included introduction of 2 new members, member news and a discussion on Liaisons goals for 2015-16.

#### 3. CRRA Liaisons Bulletin

On November 2011 the liaisons council started a monthly bulletin with news on members' professional development, achievements and conferences, as well as institutional projects and grant opportunities. 4. Survey (goals 5.2, 5.3, 5.4)

progress of 2015-2016 Council goals. The survey was distributed four times (between December 2015 and January 2016) via email to Liaisons. Twenty two member institutions responded the survey, representing a 50% response rate participation. The survey also showed satisfactory results in relation to the 2015-16 Liaisons Council goals. By January 2016 goals 5.2, 5.3 and 5.4. were considered accomplished. It is believed that the results of the survey will help the Liaisons Council and other CRRA groups to set priorities and new goals.

5. CRRA DAC/Liaisons Webinar on Collaborative Digitization (goal 5.1)

A webinar on Collaborative Digitization: The Catholic Pamphlets Project was offered on June 1, 2016, as a joint effort between Digital Access Committee and Liaisons Council. Jean McManus and Eric Lease Morgan of Notre Dame described their project to digitize Catholic pamphlets and make them available in the portal. Presenters shared their experience with in-house and outsourced digitization, workflow, connecting images to MARC records, copyright issues, etc. The webinar had an attendance of more than 21 people, considering that some sites had multiple participants

# **Newspapers Project**Announcing the Catholic News Archive

Thanks to the <u>generous commitments</u> of CRRA members and partners, we are delighted to announce that the Catholic News Archive on the Veridian platform is up and running. With pledged funds and the work of numerous sourcing partners and vendors, we have begun digitizing 32,000 pages from the Catholic News Service newsfeeds, the Miami Voice, Philadelphia's Catholic Standard and Times, and the New Orlean's Clarion Herald. This is just the beginning, stay tuned as we continue to add content as funds become available. Please have a look at the Archive and <u>send us</u> your comments or suggestions!

# **Collection Highlights**

Collection highlights from the Annual Meeting, June 7, 2016.

The fifteen <u>lightning talks by members</u> on their <u>digital collections</u> and <u>archival collections</u> were a fascinating glimpse into Catholic history. Amazing what can be said in 4 minutes. Records from religious congregations – Augustinian, Dominican, Jesuit, Ursuline, and Vincentian – were featured as was the influential Dockweiler Family Papers of Los Angeles. Prominent collections highlighted were the Marian Library at the University of Dayton and the Bureau of Indian Mission Collection at Marquette University. Digitization activities are on the rise as seen in the *METAscripta* Project digitizing manuscripts in the Vatican Film Library at Saint Louis University, the Daily Reflections Archive at Creighton, and Catholic pamphlets at the University of Notre Dame. While learning more about these collections, participants identified opportunities for collaboration in creating even more comprehensive collections, for example, around Catholic pamphlets, which were frequently published regionally, are uniquely held in member collections. Along with collections, the focus was on encouraging use. It was exciting to see the how this is happening through the <u>American Catholic History Classroom</u>, which features a range of materials for educators and researchers, and the growing number of <u>subject guides</u> available on religious congregations, African-American Catholics and *Laudato Si*, all with links to relevant materials in the portal. All CRRA members can copy and adapt the <u>subject guides</u> for local use as well as contribute or suggest new guides be created by writing to any member of the <u>Subcommittee</u> on <u>Subject Guides</u>.
